Notice of convocation of the Annual General Meeting

- 3. Discussion on the Board of Directors' business performance report, report of the Company's assets and financial performance as of 31/10/2016, business plan and the financial budget of the Company for the financial year beginning on 01/11/2016 and ending on 31/10/2017, the Annual Report as of 31/10/2016, the report of the Supervisory Board;
- 4. Adoption of the annual individual financial statements as of 31/10/2016 and the proposal to distribute the profit achieved in the financial year beginning on 01/11/2015 and ending on 31/10/2016;
- 5. Adoption of Company's auditor pursuant to § 19 Act No. 431/2002 Coll. on Accounting;
- 6. Election of a Supervisory Board member, adoption of the Agreement on the Supervisory Board member capacity;
- 7. End of the session.

The registration of Company's shareholders will take place at the venue of the Company's Annual General Meeting on 28 April 2017 from 09:00 a.m. to 10:30 a.m.

The record date for exercising the right to attend the Annual General Meeting, the right to vote there, request information and explanations and propose motions, is three days before the Annual General Meeting is held, i.e. **25 April 2017.**
